Solubility / thinnability	Generally speaking, Desmophen [®] 1100 has good compatibility with esters, ether esters, ketones and aromatics, although the solutions must be tested for their storage stability. Prolonged storage of a solution with low binder content may result in turbidity and sedimentation. Only PU grade solvents should be used (< 0.05 % water, free from other reactive impurities).
Compatibility	Desmophen [®] 1100 is compatible with polyesters, polyethers and many Desmodur [®] grades. In view of the many different products on the market, the compatibility should be tested beforehand.
Properties / Applications	Desmophen [®] 1100 is used alone or in combination with other Desmophen [®] grades to formulate two-pack PU coatings for wood finishing.
Storage	 Storage in original sealed Covestro container. Recommended storage temperature: max. 30 °C. Protect from moisture, heat and foreign material. General information: The product is slightly hygroscopic.
